We collect your data when:

- You voluntarily sign up for our newsletter or downloadable resources

4. Why We Process Your Data (Legal Basis)

5. How We Use Your Data

We may use your information to:

We do not sell or rent your data. We do not engage in automated decision-making or profiling that affects your legal rights.

6. Who Has Access to Your Data

We limit access to your data to:

- The legal data controller of ROGISTECH
- Authorized contractors (e.g., translators, developers) who sign NDAs
- Third-party services under GDPR-compliant contracts (e.g., Zoho Invoice, Google, WhatsApp Business, Canva, Stripe, etc.)

7. Data Storage and Retention

Your data is stored securely on encrypted servers and platforms. We retain:

- Client invoices and business communications for 5 years, as required by Spanish tax law
- Contact form and inquiry data for 12-24 months
- Video/audio content for 30 days post-service unless otherwise agreed

You may request deletion at any time, and we will comply unless legally obligated to retain data.
